As recommended by the Committee constituted vide Order No. 779 of DSEJ dated 20.09.2018, sanction is accorded to the grant of permission / recognition and extension in the period of recognition in favour 6+6 (12) Private Institutions as per *Annexure "A"& "B" respectively*.

Approval is subject to the condition that the management of the institution shall also adhere to the following strictly:-

 That the Building safety certificate/ Fire safety certificate shall be renewed annually from the concerned agency.

That there shall be no enhancement of the fee(s) of the students without the approval of the Fee Fixation Committee.

- That the school management shall follow all the orders pertaining to schools issued by the Govt. from time to time and the Govt. reserves the right to cancel or suspend permission, if found, indulging in activities in contravention to Orders/directions.
- That the school management shall abide by the provisions of J&K School Education Act-2002 and other orders of State Govt.
- That the school management shall remain open to inspection of the school by the designated authorities of the Govt.
- That the school management shall appoint only graduate and above candidates as teacher in future in compliance to SRO-290 dated 06-09-2016.
- That only those text books which have been approved by the J&K Board of School Education shall be prescribed for the students.
- The School Management shall adhere to the applicable Labour Laws.

The CEO, concerned shall ensure that aforesaid instructions are adhered to and complied by the school management failing which permission/recognition shall cease to exist further and shall be deemed to have been withdrawn ab-initio.

This shall be subject to outcome of pending court case(s) if any.
